Consider approval to put the old oil furnace on MuniBid to sale.

Consider approval to partner with the Clinton County Solid Waste Authority on their Residential Tire Collection Event on Friday, May 9 and Saturday, May 10 at the recycling center in McElhattan. The Borough will hold a collection on Thursday, May 8 from 7am-2pm and Friday, May 9 from 7am-11am at the Borough Building. Limit is 12 tires per resident in the Borough. Not open to tire dealers, service station operators, repair garages, tire sales outlets or similar facilities. Tire collection includes rims. Must complete manifest to drop off.

Consider approval to have the Borough Solicitor amend Part 1 of Chapter 4 of the Mill Hall Borough Code of Ordinance with respect to dangerous structures, section 4-106 from Borough Council to Appeals Board.

Consider approval to waive pavilion rental fees for the Mill Hall Kiwanis chicken bbq events on April 5, July 19, and September 27.

Consider approval to accept the Cell Phone Policy.

Consider approval to start reaching out to engineers to represent Mill Hall Borough.

Consider approval to have Ryan Kunes, Keven Hoy and Donald Miller attend the April 22 Flagger Certification Training that will be held on the Department of Community Services Building from 9am-noon at \$75 per person.

Consider approval to remove Kevin Hoy from probationary status to full-time status with a \$1 per hour increase in pay.

Consider approval to amend the Mill Hall Borough Personnel Policy to increase comp time hours.

- Employees who are eligible to receive compensatory time may accumulate up to ~~forty (40)~~ **eighty (80)** hours. Compensatory time must be used ~~within seven (7) pay periods~~ **by October 1 of each year**. Once an employee has elected to receive compensatory time off in lieu of overtime payment, he/she must either take the time off or wait until the end of the calendar year to receive payment.
