### **UNFINISHED BUSINESS**

Consider approval to adopt Ordinance 2025-3-25 that amends Part 1 of Chapter 4 of the Mill Hall Borough Code of Ordinance with respect to dangerous structures, section 4-106 from Borough Council to Appeals Board.

Consider approval to have Stiffler McGraw and Associates serve as the Mill Hall Borough Engineer.

#### **NEW BUSINESS**

Consider the hiring of Donald Miller as Park Custodian to start employment on March 31, 2025.

Consider approval to adopt Resolution 2025-03-25 declaring Mill Hall Borough's intent to follow the schedules and procedures for disposition of records maintained by the Borough as set forth in the Municipal Records Manual.
