Transit Retail Business

License required - issued by Borough Secretary

Fee shall be established by Borough Council.

Exception:

- A. Farmer selling their own product
- B. Donation to charitable organization
- C. Children under the age of 18 years
- D. Armed Service members

Exempt qualifiers still must obtain a license without fee.

13-104 Listed requirement to get license on application.

13-107 Chief of Police shall supervise activities and keep records.

13-109 Penalties \$25.00 - \$600.00 each day of violation.

ORDINANCE: Chapter 24

Mercantile Tax

101 Temporary, Seasonal any business conducted at one location for less than sixty (60) calendar days.

102 One (1) Mill Tax of gross volume

103 Business subject to tax – make quarterly returns
