**\*DISCLAIMER AND INSTRUCTIONS:**

Lessee/User shall indemnify and save harmless the Borough, its agents, officers and employees for any injury to any person or property caused by the negligence, carelessness, recklessness or intentional acts of Lessee/User or any of Lessee/User's guests or invitees in the use of the park premises. In the sole discretion of the Borough, the Borough may require Lessee/User to purchase liability insurance in amounts acceptable to the Borough, naming the Borough as an additional insured.

**\*MILL HALL COMMUNITY PARK IS USE AT YOUR OWN RISK.**

When the park or portion thereof is considered unsafe as determined by the borough employees and/or recreation committee, the park will be posted as closed and any person who has reservations affected by the closure will be notified by a borough employee as soon as possible. The borough will extend a credit for the amount of the reservation toward a future reservation.

\*Borough Secretary/Treasurer will issue reservations upon completion of application and payment by way of cash, check or money order, made payable to Mill Hall Borough, at the Borough office. **215 Beech Creek Ave. Mill Hall, Pa. 17751** (570-726-4008)

\*Borough Park Custodian will post reserved pavilion under the reservation name provided. (No transfer of pavilion shall be permitted.)

\*Driving through or on the grass areas of the park is PROHIBITED. Failure to adhere may result in a fine and loss of rental privileges in the future.

\*No Alcohol or tobacco including e-cigarettes allowed in the Mill Hall Borough Community Park.

\*Pets are welcome, but must remain on a leash at all times and scooping is required.

\*All canopy shade devices must be anchored to the ground.

\*You will have a 20-amp service in your pavilion. That may accommodate 2 small electric appliances. Short extension cords are permitted. However, power strips may cause the breaker to trip. The borough **DOES NOT** respond to a tripped breaker. If you overload your breaker, you **WILL BE WITHOUT POWER.**

\*The use of nails, tacks and/or staples to attach signs, decorations and/or table coverings is PROHIBITED.

\*We take great pride in the cleanliness of our park. We ask you to please be courteous, and kindly clean up after yourselves before leaving. Please bag all trash and place in the cans located at each pavilion.

\*Your cooperation helps to keep our rental prices down.

\*Reservation is for the entire day. Park opens at sunrise and closes at sundown.
